ADMINISTRATOR'S REPORT

Administrator Tracy Byard has been working on the 2019 budget, working with the Unions regarding different health care options, and working on the indigent defense fund.

TREASURER'S REPORT

Treasurer Jenny Beemer-Fritzinger reminded everyone that the land auction sale is scheduled for Saturday, August 4, 2018 at noon at the Doherty Hotel in Clare. Sent out second batch of delinquent tax notices, and has been helping Tracy with the budget.

COMMUNITY SERVICES DIRECTOR REPORT - Director Lori Phelps was at another meeting out of town and excused.

PUBLIC HEARINGS/SPECIAL PRESENTATION

Lou Adams with Voters not Politicians Initiative spoke about the ballot issue that will be on the November 6, 2018 ballot for a constitutional amendment for redistricting, and how the committee will be formed and who would sit on the committee.

COMMUNICATIONS LIST

Chairperson Lipovsky asked Clerk/Register of Deeds Lori Martin about Bill Scott resigning from the Board of Canvassers. Chairperson Lipovsky asked for discussion. This is to offset overtime costs by adding another part time employee. Motion carried.

Moved by Commissioner Strouse and Seconded by Commissioner Gelios to allow the Sheriff Department purchasing a K9 patrol service dog for \$8,500.00 from existing 301 and 595 funds. Chairperson Lipovsky asked for discussion. Need to replace the current K9 that needs to retire. Motion carried.

Chairperson Lipovsky asked for discussion. Administrator Byard stated it would not be more than the stated \$17,548.00, which will come from contingency, motion carried.

Clerk/Register of Deeds Lori Martin reported her office has been working very hard to prepare for the August election.

Commissioner Gelios has been attending his meetings. Hayes Township will be hiring their own IT, meeting with city of Harrison regarding ORV traffic, and talk regarding Middle Michigan.

Commissioner Majewski has been attending his meetings. Every meeting he is at is requesting more police protection with more deputies on the road. Commissioner Majewski thought the Board should re-evaluate
