Bill Strouse, Sheridan Township Supervisor was present and brought to the Board's attention a business on Colonville Road that has a parking lot that butts up to the road right of way and the danger that poses to the public.

Teagen Lafere, Financial Home Ownership Group of MSU presented to the Board of Commissioners information regarding Step Forward Michigan. She and her staff sent out 15 information packets for people that need help with their delinquent property taxes the week Treasurer Jenny Beemer-Fritzinger sent out delinquent tax notices. She also offers home buyer education, post purchase, which would be foreclosure prevention, financial capabilities, and rental education.

Marty Johnson with Friends of Clare County Parks and Recreation is selling raffle tickets to raise funds to purchase a handicap mat that will allow disabled or elderly persons to be able to get down the beach.

Mr. Johnson also spoke about Clare County Historical Society and invited everyone to the school house and show room open every Saturday.

#### ADMINISTRATOR'S REPORT

Administrator Tracy Byard attended the quarterly breakfast for MMDC (Middle Michigan Development Corporation, and reminded the Board about the 2017 Legislative Day will be July 20, 2017 at MMCC, and attended the Child Welfare Council meeting and offered an update. Administrator Byard is still working on the Budget.

#### SPECIAL PRESENTATION

John Obermesik, Executive Director of CMHCM – Mr. Obermesik was not present therefore there was no presentation.

Lisa Kaspriak, Administrator for the Medical Examiner's Office, Dr. Paul Wagner, was present to discuss cremation permits. Dr. Wagner is trying to make the counties he works for more uniform. Only about half of the counties charge for a cremation permit. They are asking for the county to charge a \$50.00 cremation permit fee for each cremation request. That would bring in an estimated \$8,400.00 per year to the County for the Medical Examiner Budget. There would then be a line item with 25% written back to the County to pay for overhead to the County.

Moved by Commissioner Gelios and Seconded by Commissioner Strouse to charge \$50.00 per cremation request as per the Medical Examiner's request. Chairperson Lipovsky asked for discussion. Commissioner Kleinhardt asked for a percentage of cremations in Clare County. Ms. Kaspriak responded 63%. Motion carried.

#### Financial Software Discussion

Administrator Byard talked about the differences between the County's current software system, Harris, and the system she would like to discuss, BS&A, and how much easier the new BS&A software would be to unify the different offices. Treasurer Jenny Beemer-Fritzinger spoke about BS&A, which is already in use in her office, and how it would help her office and the payroll department save time and reduce risk of error.

Commissioner Bristol asked where funds for this would come from. Administrator Byard explained the funds currently being paid for the current system along with funds from the 518 fund (tax reversion fund) would cover the costs.

Moved by Commissioner Majewski and Seconded by Commissioner Bristol to purchase BS&A program and to be paid out of the 518 fund (tax reversion fund) and existing funds allocated for the Harris System. Chairperson Lipovsky pointed out discussion already took place. Motion carried.

Chairperson Lipovsky asked for discussion. Hearing none motion carried.

Clerk/Register of Deeds Lori Martin gave an update on the new voting equipment delivery, which is expected in August 2017. Clerk/Register Martin also discussed a bill in the house to change candidate filing fees. Everything in her office is going very well.

## TREASURER'S REPORT

Treasurer Jenny Beemer-Fritzinger reported the land sale date will be Monday, August 21, 2017 at noon at the Doherty Hotel in Clare. There are 84 properties along with adding some of the land bank properties. A property the County has held for a long while has sold. Michigan Tax Tribunal is underway.

Commissioner Strouse has been attending his meetings. Grant Township is trying to restrict truck use on their roads. Sheridan Township does not have zoning and there are issues with a store and the parking area being in the road right of way. Commissioner Strouse read a letter he emailed to Clare County Road Commission (copy attached to minutes).

Commissioner Majewski has been attending his meetings. Reminder Waste Management household hazardous waste disposal will be at Northern Oaks from 10:00 a.m. – 2:00 p.m. on Wednesday, September 13, 2017. Commissioner Majewski read a letter he received from a 4-H member regarding the horse program.

#### **PUBLIC COMMENT**
